# **Health Services Management**

## **Objectives:**

Understanding the principles of Public Health and Health Services Administration through the eyes of a health economist/physician/administrator in meeting the requirements of the American Board of Preventive Medicine are the primary objectives of the course. In addition, students will learn about the inefficiencies of the United States healthcare systems in meeting the needs of the public. This course will assist the practitioner/researcher in understanding how to succeed in these systems.

### Grading:

Attendance and participation in class demonstrating and understanding of the material (50%) Proposal Paper (50%):
